60 Years Ago, April 7, 1966
Vote official, despite quirk

A rebellious voting machine spring has been officially blamed for voiding 143 "yes" votes during last week's overwhelming affirmative vote for construction of a new town hall and library.

Grand Island voters went to the polls March 23 to cast their ballots concerning the proposed construction on the \$650,000 project, which is expected to begin in a few months on the present site.

When all the votes were tabulated, however, a strange trend was noted. There were three blank ballots on one machine and a very unusual 143 blank ballots on another machine.

As is the custom in such instances, the machines were sealed and the Board of Elections was called. A team of mechanical experts soon arrived to examine the machines, headed by assistant election commissioner, Harold V. Doney.

It was a tense moment, no doubt, because the original vote to approve the construction was 503 votes in favor and 324 against. But the inspectors found the pesky machine was dropping "yes" votes. This means that the referendum passed by an even greater margin.

Bible Presbyterian Church to open Christian School

The Rev. Robert Vandermey of the Bible Presbyterian Church on Love Road announced last Wednesday that they were planning on opening a Christian School on Grand Island in September.

The school was approved March 31 by the congregation after hearing results of a study made under the direction of the church education committee chaired by Frank Williams. The necessary research to complete this study took two years and many man-hours of the committee's dedicated members. ...

Rev. Vandermey said the school will "stress biblical Christianity, patriotism, discipline and academics," as well as provide music, art and physical education. He felt there are many parents who would like Christian education included in the curriculum for their children.

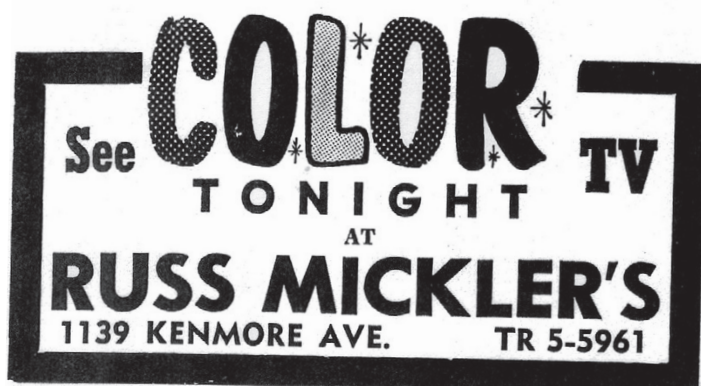
10 Years Ago, April 8, 2016
