

# NT students help brighten Valentine's Day

It's been a challenge for National Honor Society adviser Tammy Stawisuck to help NHS students complete their community service hours this year.

"With the pandemic, it limits the things we usually do as far as our worthy endeavors," she said. "We have tried to be creative as we can with doing things online and from home. So far this year, we have raised money for breast cancer awareness with the Go Pink campaign; sent letters to our hometown heroes who are working as nurses on COVID hospital floors; and committed random acts of kindness like leaving decorated pumpkins on people's porches. We have been striving to do something that is meaningful for the students and would lift their spirits, as well. It has been a hard school year."

The students' recent endeavor was showing residents of Bishop Gibbons Apartments in North Tonawanda a little love on Valentine's Day. Drake Elementary School Principal Janet Matyevich suggested the idea when her school's foster grandmother, Peggy, mentioned residents weren't allowed visitors, and how hard the recent holiday season was on them.

Stawisuck said her students were enthusiastic on the idea of adopting 40 residents and making them goody bags. "Each student got a name and made the resident a card and filled a bag with little gifts. It was such a nice project because, not only did the students get service hours, they really brightened somebody's day and felt inspired by the project," she said.

Matyevich gathered the beautifully decorated bags and delivered them to the senior housing complex.

"The bags were lovely and I was so proud of the high school kids and the effort they put in to make it special," she said. "I actually got quite emotional of the residents' reactions. They are really locked down and can't even be allowed to congregate or play cards and they were so appreciative of receiving these gifts."

Watch doesn't take on just anything, and what they do take on, they do it; they do it well," Pecoraro said.

Due to the outbreak of COVID-19 last year, a similar effort was canceled. This, Marranca said, was one of the driving reasons for trying to put an event on this year, as he wants to see it become a more rich tradition in the city.

"We're hoping maybe this would be just the start of something that would be wonderful for our city, because I know we have such a rich Polish heritage and I believe it's a no-brainer," Marranca said. "Thinking about life after COVID-19, I can see this becoming a yearly tradition."

to do whatever is necessary to make it happen.
