

Town of Lewiston, City of Niagara Falls to distribute COVID-19 at-home testing kits

The Town of Lewiston will hold a distribution of COVID-19 at-home testing kits on Saturday, Feb. 12, in the Town Hall parking lot, 1375 Ridge Road.

Open to Town of Lewiston residents only, the distribution effort opens at 9 a.m. and continues to 1 p.m., or when supplies are exhausted.

Each household will be provided two kits, with each kit containing two COVID-19 tests. The distribution will be on a first-come, first-served basis. Town residents are asked to bring proof of identification. Acceptable ID includes a driver's license, a utility bill, tax bill or a government-issued ID.

When arriving, residents are asked to follow the guidance cones at the distribution site.

No pre-registration is required. Those looking to claim a kit must have photo identification. There is a limit of two kits per household.

#VaxForKids event at Seneca Niagara Resort and Casino

Parents and guardians can learn more at ny.gov/vaxforkids; includes resources for organizations hosting #VaxForKids events Gov. Kathy Hochul announced new #VaxForKids pop-up vaccination sites to increase vaccination rates among children and adolescents. The new sites support the state's goal of ensuring New York children 5 years and older get vaccinated and keep up with all recommended coronavirus vaccine doses, including the booster. The State Department of Health is working with localities, community-based organizations, and health care centers on-the-ground to establish these sites in all regions of the state. Partners, host sites and outreach efforts will be tailored to best meet the needs of the communities they serve.

State Health Commissioner Dr. Mary T. Bassett said, "In partnership with community-based organizations, 58 new #VaxForKids sites are coming online this week, so getting children vaccinated is even easier for parents and guardians. Without protection from the COVID-19 vaccine, children remain at risk for severe disease and even hospitalization. We urge parents and guardians statewide to get their children fully vaccinated and boosted, when eligible. Vaccination is their best protection against the virus."

A community-based medical professional will be available at each site to answer any questions

parents and guardians may have. #VaxForKids will be held from 2-6 p.m. Wednesday, Feb. 9, at the Seneca Niagara Resort & Casino's Seneca Niagara Events Center, 310 Fourth St., Niagara Falls. Vaccine types include Pfizer-BioNTech, Janssen/J&J, Moderna and seasonal flu.

The Niagara County Department of Health is the event partner.

In addition to the state's pop-up and mass-vaccination sites, New Yorkers can visit vaccines.gov, text their ZIP code to 438829, or call 1-800-232-0233 to find nearby locations. Parents and guardians can also contact their child's pediatrician, family physician, county health departments, Federally Qualified Health Centers (FQHCs), rural health centers, or pharmacies that may be administering the vaccine to this age group.

Fort Niagara offers special admission for Lincoln's birthday

Old Fort Niagara invites readers to celebrate President Abraham Lincoln's birthday on Saturday, Feb. 12, with a special discount admission at the historic site in Youngstown.

That day, the fort will offer a special \$5 cash-only admission for visitors. OFN said those who pay with the \$5 U.S. bill bearing Lincoln's portrait will be able to gain admission at a fraction of the regular cost, while enjoying special programs about local history during Lincoln's time.

Normal admission prices are

\$17 for adults and \$12 for children.

"This is a great way for local families to enjoy the fort at modest cost," said Robert Emerson, executive director of Old Fort Niagara. "We will be offering special programs on Lincoln's birthday focused on the Civil War, when he was president."

Emerson noted that, at the onset of the Civil War, Fort Niagara was garrisoned by elements of the Seventh U.S. Infantry Regiment. This unit was captured by the Confederates in New Mexico in July of 1861 and sent to northern border posts on parole the following winter. Later, the Union strengthened Fort Niagara by adding the massive brick walls that remain a prominent feature of the fort today.

Currently, Old Fort Niagara is open from 10 a.m. to 4 p.m. Friday through Sunday. For more information on Old Fort Niagara and its many historical programs, visit www.oldfortniagara.org.
