"The fact that it is patio homes will broaden the appeal of what might have been a single-family home project," he said. He sees that appeal as a lifestyle, one he has seen grow in other developments.

"When I say lifestyle, it's not only lifestyle of the product you're living in. It's a lifestyle of the neighborhood you're living in. These patio home projects create ... I guess going back to the old days where neighbors used to really be neighbors and be involved with each other. I see book clubs being developed, and dinner clubs and golf leagues and picnics and various forms of social interaction. It's been interesting to watch it evolve that way.

"I have a feeling in Lewiston we might attract a slightly expanded product mix and profile than what we're attracting. The reason is that what I'm being told by the Realtors in the community is that there not a lot of new construction being offered (in Lewiston)."

And he identified the very flexibility of the patio home design, the

ease-of-living community around it.

"By default it attracts empty-nesters," Nanula said. "We don't age restrict any project. They're typically smaller lots. Houses are a little bit closer together. The maintenance aspect is unique in that we have a homeowner's association, and it takes care of all the exterior maintenance."

Nanula noted he's seen a lot of empty-nesters with older children and grandchildren opt for additional second-floor space, who want a guest space that doesn't affect the main floor living area.

As a long-time board of director member of the Buffalo Niagara Builders Association, and a member of both the New York state and National Builders' associations, Nanula and his Essex Homes of WNY are looking forward to bringing an experienced take on home building in Lewiston.

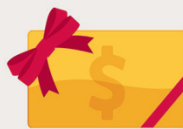
